The Older Adult Self-Report for Ages 60 and Above (OASR 60-90) was completed by Jose, to obtain his perception of his adaptive functioning, substance use, and problems.

On the OASR/60 and Above - Adaptive Functioning Scale Scores, Jose's score on the Spouse/Partner scale was in the clinical range below the 3rd percentile. Jose's score on the Friends scale was in the borderline clinical range (3rd to 7th percentile). Jose's score on the Personal Strengths scale was in the normal range. Jose reported his marital status as never been married.

On the OASR 60-90 problem scales, Jose's Total Problems score was in the clinical range above the 90th percentile for men aged 88. His scores on the Worries and Memory / Cognition Problems syndromes were in the normal range. His score on the Functional Impairment syndrome was in the borderline clinical range (93rd to 97th percentile). His scores on the Anxious / Depressed, Somatic Complaints, Thought Problems and Irritable / Disinhibited syndromes were in the clinical range above the 97th percentile. These results indicate that Jose reported more problems than are typically reported for men aged 88, particularly problems of Anxious / Depressed, Somatic Complaints, Functional Impairment, Thought Problems and Irritable / Disinhibited nature. Jose's scores on the Critical Items are listed in the box below. The sum of Jose's scores on the Critical Items was in the clinical range above the 97th percentile.

On the OASR/60 and Above - DSM-Oriented Scales, Jose's score on the Dementia Problems scale was in the normal range. Jose's scores on the Depressive Problems, Somatic Problems, Psychotic Problems and Antisocial Personality Problems scales were in the clinical range above the 97th percentile. These results indicate that the DSM should be consulted to determine whether Jose meets diagnostic criteria for Depressive Problems, Somatic Problems, Psychotic Problems and Antisocial Personality Problems. Jose's score on the Anxiety Problems scale was in the borderline clinical range (93rd to 97th percentile). Jose's score in the borderline clinical range suggests that the DSM should be consulted to determine whether Jose might meet diagnostic criteria for disorders characterized by problems included on that scale.

Critical Items

In addition to the scale scores, it is important to consider scores on individual problem items. Because they may raise particular challenges for management, it is especially important to note the problems listed below that were reported with scores of 1 or 2. Look at comments made by the informant on the form in relation to these problems to obtain more information about risks associated with the problems and the contexts in which the problems occur.
